## Electronic Payment Instructions

A. The Electronic Payment Authorization statement authorizes Broadridge Corporate Issuer Solutions, Inc. to electronically credit your dividends directly into your account at your financial institution.

B. Please be advised that a 5 business day hold period exists for the establishment and/or change of banking instructions on an account.

C. The following items regarding your financial institution are required on this coupon. Missing or incomplete data will result in return of the coupon.

1. Your financial institution's SWIFT Code or Bank Identifier Code (BIC) – the 8 to 11 character international bank code that identifies your bank. This typically includes a 4 digit bank code, a 2 digit country code, a 2 digit location code and an optional 3 digit branch code.

2. Your financial institution's International Routing Code (IRC) – a routing code used to aid in routing the payment to your bank account. Different countries may have different names for this code. Example: Sort Code in the United Kingdom, Canadian Payments Association Routing Number in Canada
3. Your International Bank Account Number (IBAN) – a code up to 34 characters long, containing numbers and letters, which contains information about the receiving country, bank, branch, and account number.
4. The name listed on your account at your financial institution.
5. The name of your bank or financial institution.
6. Your financial institution's address.
7. If your financial institution uses an intermediary bank in the U.S. to assist in the transfer of funds, please provide the intermediary bank's name. Please confirm with your financial institution if an intermediary is used.
8. If your financial institution uses an intermediary bank, please provide the intermediary bank's SWIFT Code or ABA. Please consult your financial institution for this information.
